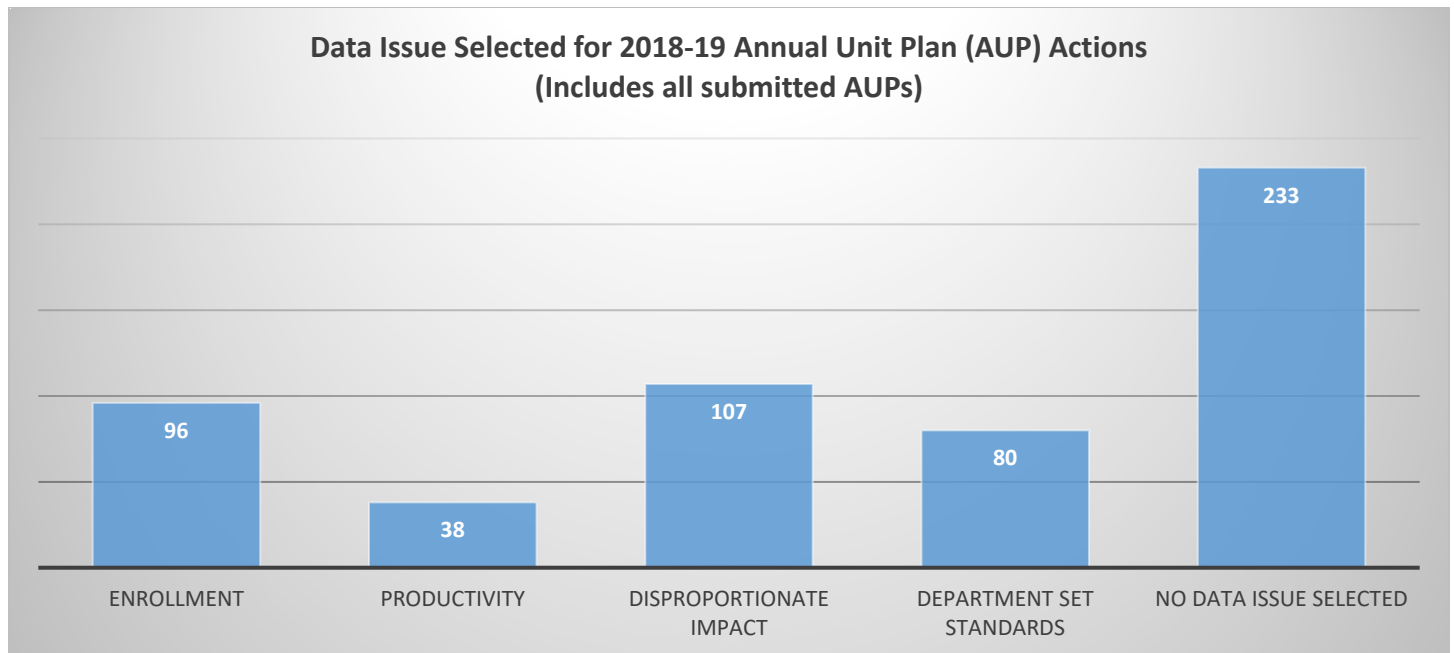
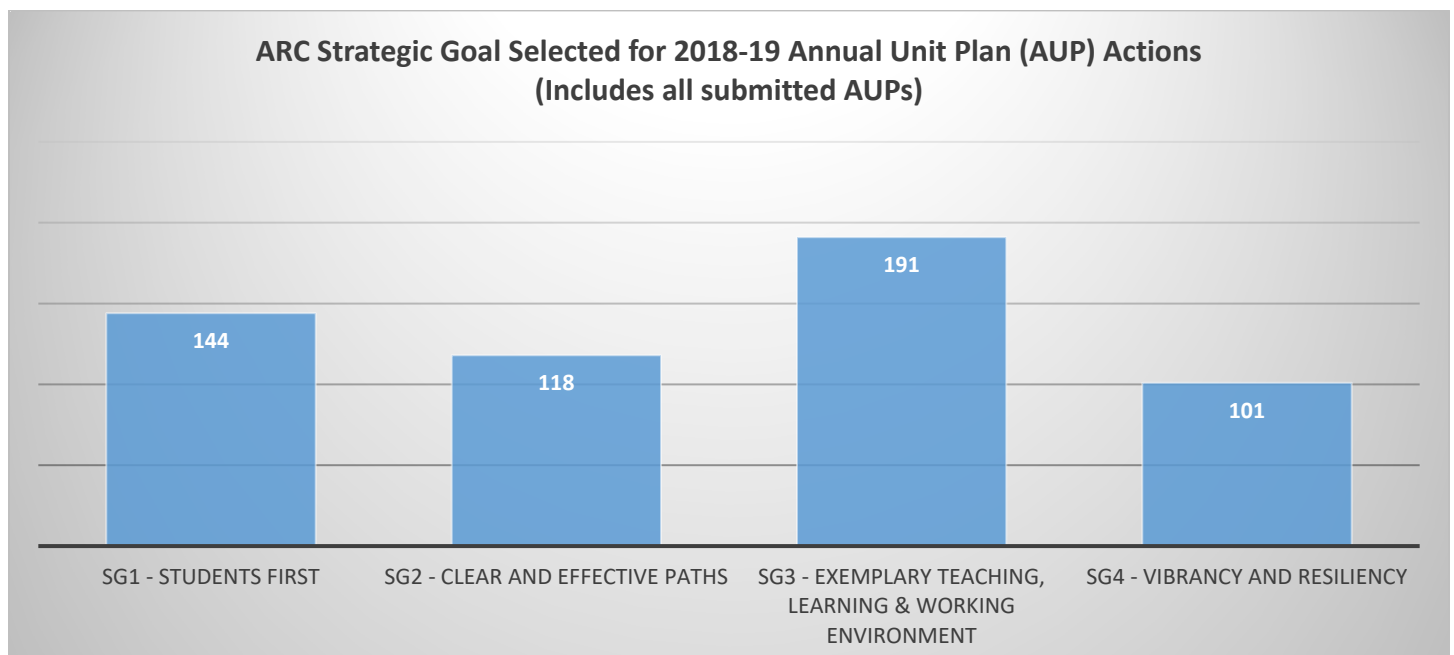


Summary of (1) Data Issues, ARC Strategic Goals and Objectives Addressed by Actions, and (2) Associated Resource Requests in 2018-2019 Annual Unit Plans

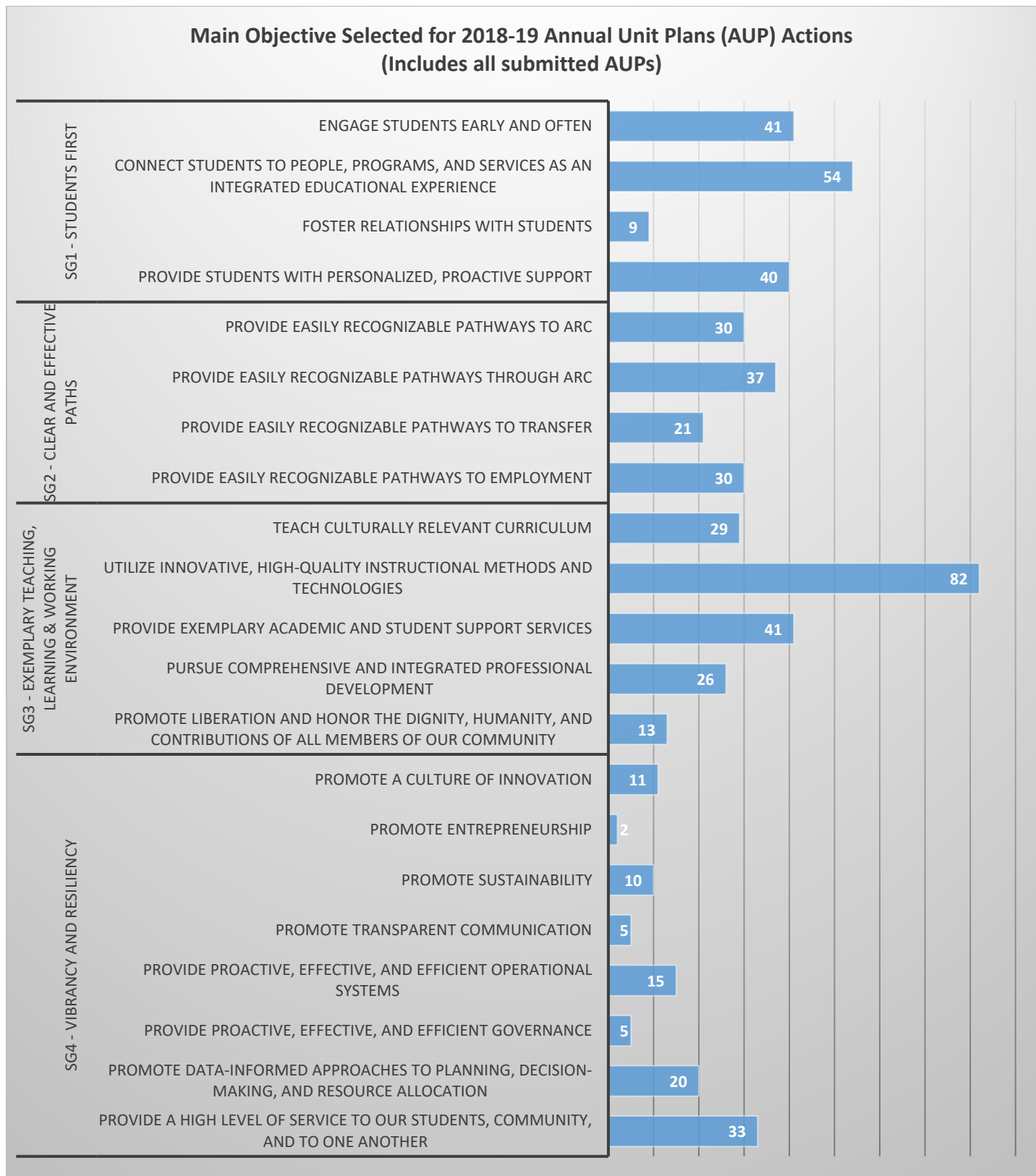
Data Issues: When a data issue was being addressed by an action, **disproportionate impact was the most frequently selected** data issue (107), followed by enrollment (96), department set standards (80), and productivity (38).



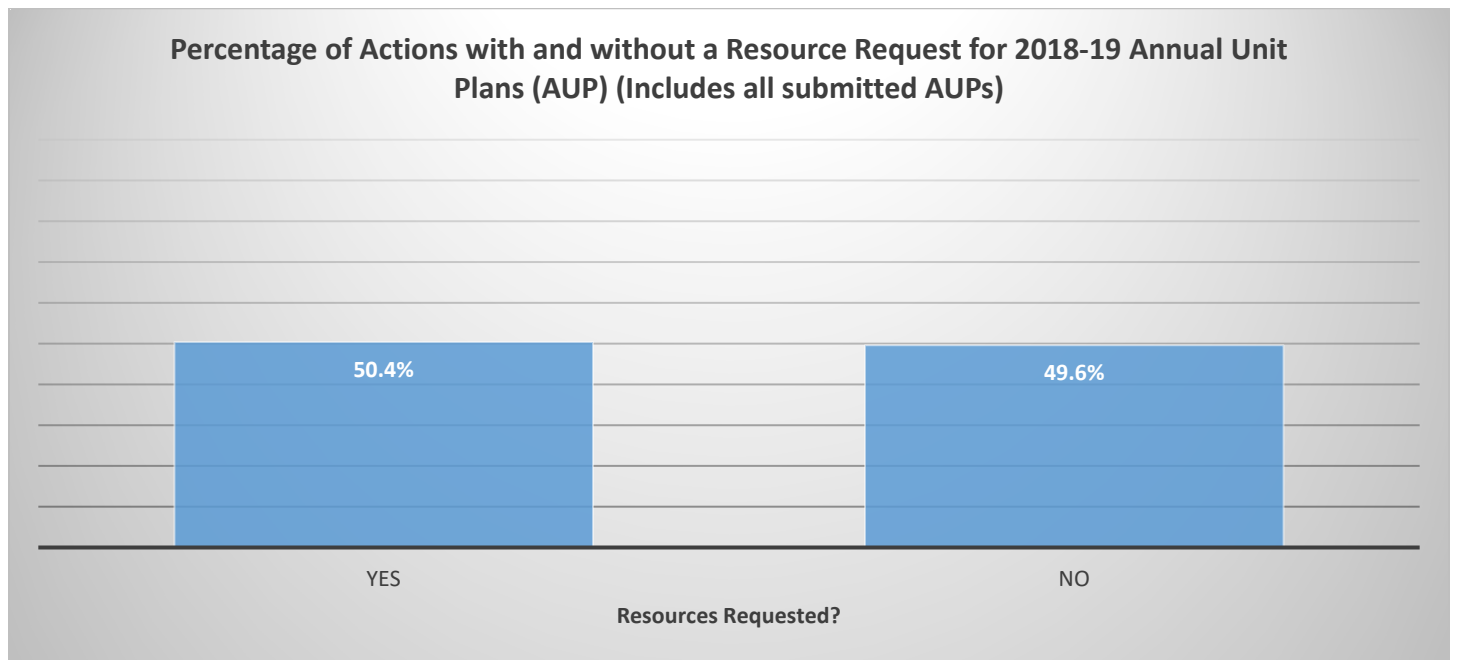
ARC strategic Goals: **SG3 - Exemplary teaching, learning, and working environment (191)** was the most frequently selected strategic goal being addressed by an action, followed by SG1 - students first (144), SG2 - clear and effective paths (118), and SG4 - vibrancy and resiliency (101).



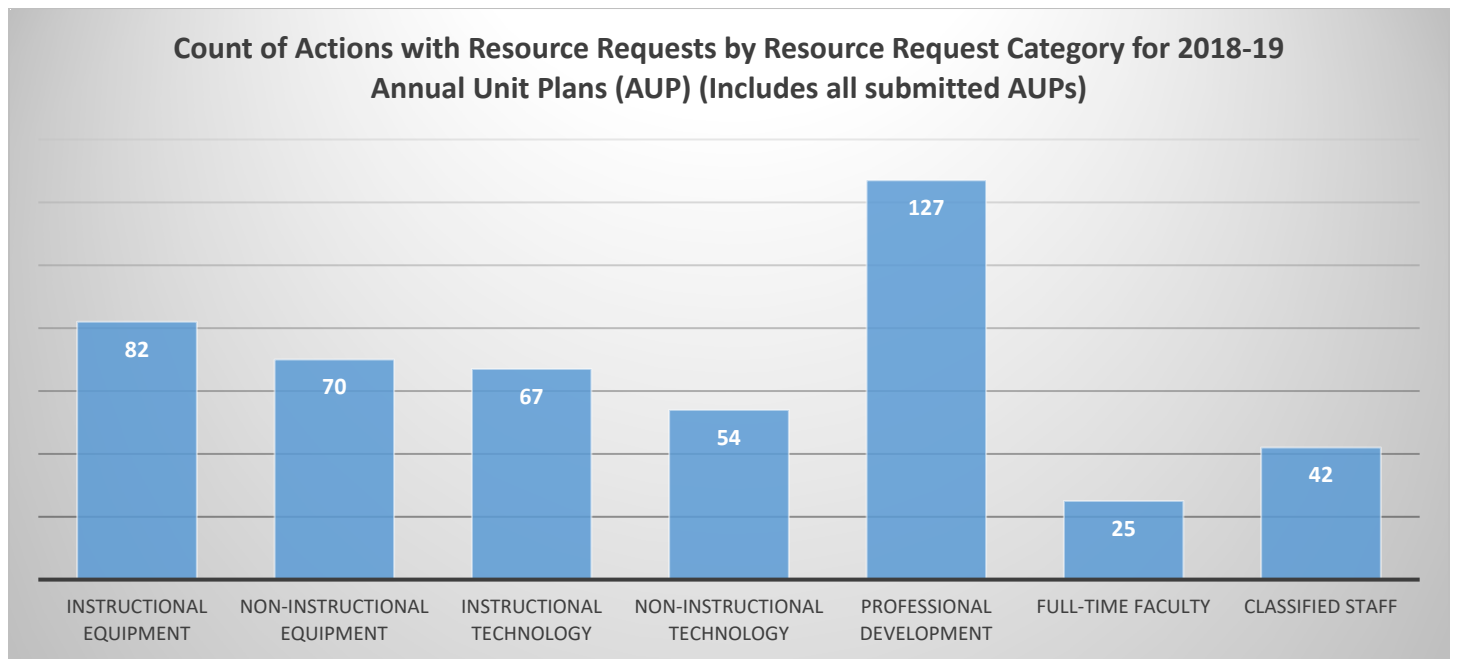
Objectives: “Utilizing innovative, high-quality instructional methods and technologies (82)” was the most frequently selected main objective. Other frequently selected objectives included “connecting students to people, programs, and services as an integrated educational experience (54)”, “engaging students early and often (41)”, “providing exemplary academic and student support services (41)”, “providing students with personalized, proactive support (40)”, “providing easily recognizable pathways through ARC (37)”, and “providing a high level of service to our students, community, and to one another (33)”.



Resource Requests: Nearly an equal number of actions were submitted with and without a resource request. Specifically, 50.4% of actions included a resource request (279/554) while 49.6% of actions did not include a resource request (275/554).

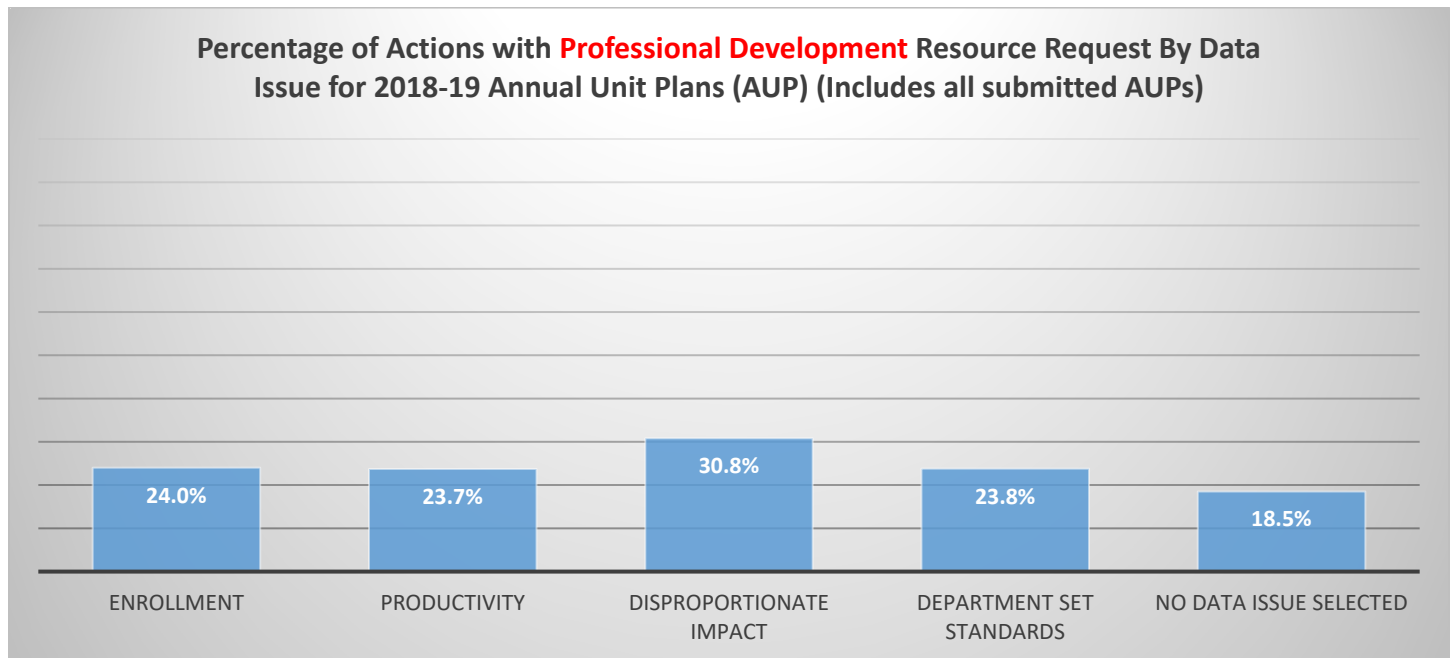


Resource Request Type: Professional Development was the most frequently requested resource (127), followed by equipment, technology, staff and faculty.

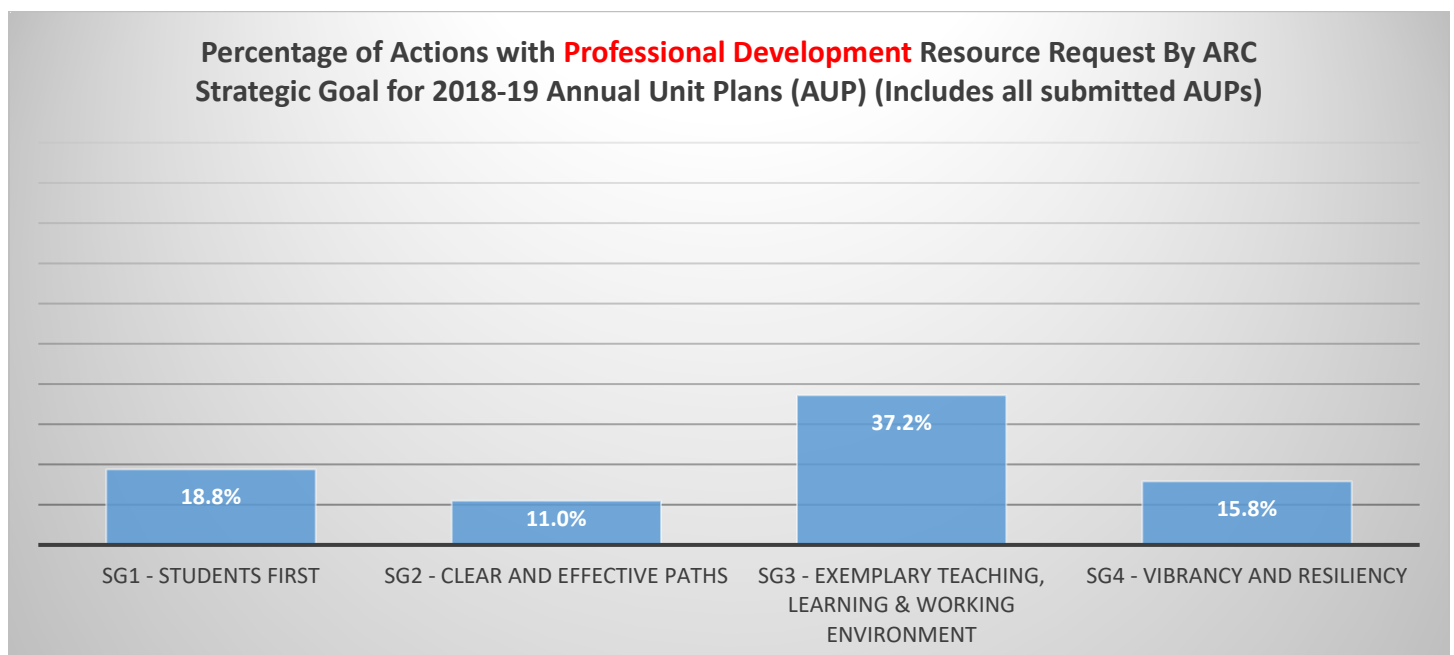


As professional development was the most frequently requested resource, the following analyses were conducted to understand the relationship between professional development resource requests and the type of data issues and ARC strategic goals being addressed.

Professional Development Requests By Data Issue: Professional development requests were most highly associated with disproportionate impact. Specifically, of the 107 actions addressing disproportionate impact, 33 of these actions included a professional development request, producing a 30.8% professional development request rate (33/107). The professional development request rate was 24.0% for enrollment (23/96), 23.8% for department set standards (19/80), and 23.7% for productivity (9/38).



Professional Development Requests By ARC Strategic Goal: Professional development requests were most highly associated with SG3 - Exemplary teaching, learning, and working environment. Specifically, of the 191 actions addressing SG3, 71 of these actions included a professional development request, producing a 37.2% professional development request rate (71/191). The professional development request rate was 18.8% for SG1 - students first (27/144), 15.8% for SG4 - vibrancy and resiliency (16/101), and 11.0% for SG2 - clear and effective paths (13/118).



Resource Requests by Objectives: Resource requests were most frequently associated with the “Utilizing innovative, high-quality instructional methods and technologies” objective (61 resource requests). Every objective was associated with at least one resource request.
