

Performance Metrics Executive Summaries Enrollment

In F21, ARC enrolled 52,309 students in its credit program (excludes 4,867 Public Safety and Apprenticeship students), a decline of 19% from Fall 2019, two years prior. When disaggregated by race, the largest enrollment declines between F19 and F21 were of students identifying as African American (-24%), White (-21%), Asian (-19%), Filipino (-18%), and Hispanic/Latino (-18%). During this same two-year period, the enrollment of male students declined by 26% (a loss of 7,268 students), compared to a 15% decline in the enrollment of female students (-1,605). Between F19 and F21, the enrollment of students with disabilities declined by 49% (-1,605), foster youth students declined by 41% (-61), full-time (12+ units) students declined by 28% (-7,784), students identifying as unhoused declined by 45% (-124), and Promise Grant (BOG) recipients declined by 26% (-11,649).
