# American River College Senate Resolution

## ASB Student Senate "Nothing About Us Without Us" Resolution

## Supporting Native American Sovereignty and Self-Determination

## Sponsors: Samaya Caraveo, Director of Legislative Affairs Jerry Kennedy, Director of Finance

## BACKGROUND

The Student Senate of American River College (ARC) has been asked by a coalition of American Indian students and their allies to add our voice in support of their desire to increase American Indian representation, not only in ARC's curriculum and student population, but in the makeup of ARC's Administration, Faculty, and Classified Staff, as well as to include comprehensive American Indian consultation on matters pertaining to the hiring of such. As the Student Senate considered this a reasonable request and within the scope of the Student Senate's role, an ad hoc committee was assigned to investigate the matter and recommend a course of action to the Student Senate as a whole. After extensive research and deliberation, the ad hoc committee presents the following Resolution and encourages the ASB Student Senate to adopt it without delay. This committee would like to acknowledge the work of the American Indian students of American River College in bringing this issue to the Student Senate and for authoring the original draft of the Resolution, the language of which has been replicated extensively in this version of the Resolution.



**WHEREAS** American River College has one of the largest American Indian populations at any community college in the State of California (as of Fall 2022, data from the <u>Integrated</u> <u>Postsecondary Education Data System (IPEDS) Fall Enrollment</u>);

**WHEREAS** academic courses substantially dealing with American Indians or American Indian issues should be taught with the utmost accuracy and sensitivity to ensure an appropriate portrayal of historical and contemporary perspectives;

**WHEREAS** the influence of colonizer attitudes is embedded within academia, leading to potential biases and inaccuracies in the teaching of American Indian history and culture, and the white-washing of American Indian history and the misrepresentation of their experience within educational material has long been an issue within academia;

**WHEREAS** the July 2019 American River College Institutional Equity Plan, under the heading Campus Climate (p. 12) states, "Marginalized populations often do not feel included or a part of the ARC community, and state they have limited or no physical symbols of belonging and inclusion that intentionally represent marginalized groups," and that "Marginalized populations [are] seen as problematic when they raise equity issues;"

**WHEREAS** the report "Exploring Disproportionate Impact: Native American," published by the Native American Student Report Team at American River College states, "There is a clear moral imperative to provide equitable access and support in education . . . *it is only through authentic relationship and engagement with the Native community that outcomes for Native American students can be improved*," (p. 3, italics ours);

WHEREAS the same report listed among its Recommendations (pp. 33-34):

- Systematic employment of a sovereignty frame to inform and enrich instruction, operations, construction, planning, and hiring;
- Creation of a roster of validated, Tribal-approved consultants to provide individual and small-group training to ARC employees in the areas of American Indian cultural awareness;
- ARC teachers and counselors trained in cultural awareness regarding American Indians as well as microaggression avoidance;



 Meaningful, formal partnerships with regional California American Indian Nations;

**WHEREAS** the Student Senate of American River College is in full agreement with the "Declaration of Native Purpose in Higher Education" (published by the American Indian College Fund), in particular, that "colleges and universities have a duty to cultivate an ethic of care in supporting Native peoples by listening, learning, and engaging with Native students, staff, and faculty" by forming "committees and listening groups on campus to better understand Native student needs and social context when creating policies and programs that impact them" (p.11);

## THEREFORE,

**BE IT RESOLVED** that, in order to ensure that accurate and culturally sensitive materials are used, thus preventing the misrepresentation and white washing of American Indian history and culture, this Senate Body strongly recommends the continuation, expansion, and transparent reporting of ARC's commitment to comprehensive American Indian consultation for faculty selection for all courses substantially focused on American Indians or American Indian issues, regardless of the academic department in which they are taught;

**BE IT FURTHER RESOLVED** that this Senate Body fully supports the recommendation of our American Indian students that this consultation process should actively engage American Indian communities, leaders, and organizations to provide input and guidance in the selection of faculty who possess the necessary cultural competence and understanding to teach American Indian courses effectively, with an explicitly stated preference for American Indian instructors in accordance with the spirit of U.S. Public Law 93-638, the Indian Self-Determination and Education Assistance Act;

**BE IT FURTHER RESOLVED** that this Senate Body strongly recommends the continuation, expansion, and transparent reporting of ARC's collaboration with the American Indian communities, leaders, and organizations to ensure that both parties have the necessary resources and support to actively participate in the consultation process, thereby aiding in building relationships and promoting cultural exchange between ARC and the American Indian communities it serves;



**BE IT FURTHER RESOLVED** that this Senate Body strongly recommends the continuation, expansion, and transparent reporting of the development and implementation of comprehensive professional development programs designed to enhance all faculty, classified staff, administration, and constituency group leader's understanding and awareness of American Indian history, culture, and contemporary issues; and to address the biases, stereotypes, and colonizer attitudes that currently exist within the culture of academia, thereby fostering a more inclusive and accurate representation of American Indian perspectives;

**BE IT FURTHER RESOLVED** that this Senate Body strongly recommends that ARC establish a comprehensive annual review process in collaboration with local American Indian communities, leaders, and organizations to assess the effectiveness of American Indian consultation for faculty selection for courses substantially focused on American Indians or American Indian issues in order to ensure that the consultation process remains transparent, accountable, and responsive to the needs and concerns of American Indian communities and American Indian students on campus;

**BE IT FURTHER RESOLVED** that this Senate Body strongly recommends the continuation, expansion, and transparent reporting of ARC's efforts to actively promote diversity and inclusivity within its faculty by 1) giving serious consideration to the challenges that arise from instructors teaching about the issues of underrepresented communities when they don't have lived experience within those underrepresented communities, and 2) initiating efforts to ensure representation of a broader range of perspectives and experiences to overcome these challenges through the recruitment and retention, with American Indian consultation, of faculty members from such underrepresented communities, particularly with regards to courses substantially focused on American Indians or American Indian issues; and

**BE IT FINALLY RESOLVED** that this Senate Body strongly recommends that ARC's Administration, Academic Senate, and District Administration shall disseminate this Resolution among all faculty, staff, and administrative employees to raise awareness of the importance of American Indian consultation in American Indian subject matter and its impact on fostering accurate and equitable educational opportunities for American Indian students.

# American River College Senate Resolution

## **Governmental Stipends**

WHEREAS, the ASB's reach and influence on campus is limited in scope;

WHEREAS, Incentives for joining and participating in the ASB are low;

WHEREAS, the Senate is under-staffed, under-utilized, and underrepresented in Campus Life

**WHEREAS,** a larger, fuller and more motivated ASB is objectively good for the students by means of a more impactful ASB

WHEREAS, It is the role of the ASB to vitalize the lives of those on campus, by virtue of events, clubs, and other key decision-making levers;

**WHEREAS**, The ASB has an obligation to support its students by extending its influence and creating student cultures



## THEREFORE,

**BE IT RESOLVED**, that the Student Senate of American River College approve of a funding structure for "Governmental Stipends" to be allotted to all members of the American River College Associated Student Body Student Senate and Club & Events Board (CAEB).

**BE IT FURTHER RESOLVED,** the proportion of senatorial stipend payout will depend on 2 primary factors; Attendance & Rank.

**BE IT FURTHER RESOLVED**, Governmental Stipends will be awarded at the end of each semester, dependent on the individual member's attendance of Meetings. Full Attendance is to be receiving of a full governmental stipend matching the individual's rank. Partial Attendance will receive a reduced senatorial stipend of 50% of the full amount after 1 unexcused absence, reducing to no stipend if 2 meetings are unexcused absences.

**BE IT FURTHER RESOLVED,** Excused absences are hereby defined as being absent due to one of the following; Sickness, Emergency, or Medical Appointments. The Senate may also vote, by unanimous consent, to decide if an individual's absence is excused or unexcused on an individual basis for reasons not defined here.

**BE IT FURTHER RESOLVED,** Members who are appointed or otherwise join outside the usual start may or may not be compensated fully, by half, or not at all from their attendance rank amount upon the determination by the Senate of the particular situation of the individual.

**BE IT FURTHER RESOLVED,** Rank determines the amount any individual within the ASB can receive, assuming full attendance. These "ranked" amounts are hereby split as such; President – \$300 Vice president – \$275 Director/Whip Positions – \$250 Legislative Analyst – \$225

CAEB Historian - \$225

**BE IT FURTHER RESOLVED,** Additional Stipends, known as "Triumphs (Triumph Bonuses)" can be awarded to individual ASB Members with  $\frac{2}{3}$  Approval from the senate. These Triumphs can only be given to the amount of \$600 minus the amount the individual is given from their rank, per semester.

**BE IT FURTHER RESOLVED,** Triumph Bonuses are hereby defined as: Bonuses awarded for completion of a major project or task outside the regular duties of the office which has an outsized positive impact on either the ASBARCSS or the Student Body.

**BE IT FURTHER RESOLVED,** This Resolution requires the co-passing of a Bill each academic year which allocates the necessary funds to bring the stipend portion of the Resolution to fruition. The Bill shall hereby be to the amount of \$15,200 (The full academic year cost of paying a FULL Senate & CAEB), but may increase this if circumstance requires it. The Senate is hereby required to pass a Bill funding the stipends during the 1st session of every academic year, and the ASB Advisor is charged with ensuring this requirement is met.

**BE IT FURTHER RESOLVED,** Triumphs are funded by a separate bill that must be passed alongside Senatorial approval of a Triumph to an ASB Member.

**BE IT FURTHER RESOLVED,** the details of this resolution (the stipend types, how it is to be paid, to whom, when, under what circumstances, and all other details, including the authorship of this resolution etc.) are to be enacted as new Bylaws. This clause is to take immediate effect upon dispersion of approved funds.

**BE IT FURTHER RESOLVED,** in the event that the 'Student Activities Fee' or any such other similar mechanism is put into effect which funds the senate beyond 2x of its current annual income, the ranked amounts each position receives shall be automatically & immediately, without vote, increased by a factor of 2. (E.X President's pay would increase from \$300 to \$600)

**LET IT FINALLY BE RESOLVED,** a rescind clause is included within the bylaw that defines the above, that with a % approval of the Senate, the bylaw is nullified and payment obligations are no longer binding for future payments.
