5. Public Comment Period (3 minutes per speaker)

Glenn Jaecks: Attended the Facilities Master Plan session today and learned that the Davies Hall replacement budget is \$68 million. Worried about the future cost of buildings moving forward.

Andrew Fix: Interviewed for a full-time position and the writing sample asked him (and other candidates) to write an email to a student experiencing housing and food insecurity. Seems like housing services needs a lot of attention. Housing insecurity among students is on the rise and Andrew is worried about the funding and staffing of the office tasked with supporting housing insecure students. Asks for Senate to advocate for improvements to the services by contacting Doreen Scott, who is in charge of that office at ARC.

Jeff Sacha: Reminder to submit nominations for the 2025 Ken Deibert Award

Ricardo Caton: Dual Enrollment issue: the gap in the scheduling. Requests to assign faculty to dual enrollment courses are happening late and makes it hard for department chairs to navigate. Urges the consideration of a dedicated full-time instructor to teach these courses (via future full-time faculty prioritization).

Tak Auyeung: The LRCCD is considering an RFT for the bookstore vendor that includes an "inclusive access program" at the District. CRC has already passed a resolution to discourage the practice of automatic billing. This may need to be discussed in the Fall as long as the decision has not been made.

Alisa Shubb: Attended the Chancellor's search open forum on Monday (with Veronica Lopez) that was run by the search firm and Trustee Ortiz. There is a spot on the webpage for input on the chancellor's search. The survey closes on Friday, May 9th by 5 pm. The link can be found in the President's Report in the "supporting materials."

10. Student Success Council (Brian)

Neue Leung will be the new faculty co-chair of the Council

There is a survey soliciting feedback on things we want or need the Student Success Council to do in the 2025-26 school year

12. Institutional Effectiveness Council (Jeff)

Action Charter was revised and put forward to ELT for adoption for the next three years.

Affordable Learning Materials Committee (Tak)

Growing the number of academic programs that offer full-OER/ZTC pathways

Reminder to report ZTC/OER status of your courses in order to document how many courses are offered to them.

Next semester's focus: how to make OER sustainable once funding runs out.

In the Fall, three student interns will be hired to help the campus complete the ZTC pathways objective.

Concern about the impacts of the bookstore offering "inclusive access"

Bookstore RFP discussion: Koue has expressed resistance to the District's pressure of have "inclusive access" from a bookstore. Senate leadership agreed. Further, there are ASCCC resolutions about not supporting "inclusive access" from bookstores.

14, Distance Ed Committee (Pamela)

Just getting started as a committee and are excited about their work.

Zoom recordings that are older than one year are going to be deleted from Zoom (see the District emails and ITC's Wednesday newsletter).

Links to video guides in Canvas will soon break because the District has shifted to Al support (and a move away from the older video guides).

Canvas has no intention of enforcing the use of any apps or Canvas features.

New Canvas feature: make sustaining accommodations to Canvas Quizzes.

Discussion Board updates

Enhanced Rubric - can move around your criteria around

Can preserve the groups from past classes

Discussion Checkpoints are coming, some institutions have turned it on, but not Los Rios. Waiting to see how things shake out.

For users of Go React (app): the vendors have quoted the District a really high price point. Faculty who use this app are encouraged to lean on their contacts to try and get a lower price. The contract ends in October, so it may be unavailable in the Fall.

Alternatives for faculty who use it?

The District is exploring alternatives, but there is no other product/app that provides all of the features/functionality of Go React.

Are there any tools being screened for screening for AI?

The approach currently is for AI tools that are opt-in or opt-out (no tools will be incorporated that you cannot choose to use or not use)

Is there a delay in creating Canvas shells for courses that have the new CALGeTC numbers?

There was an impact on English courses, but it should be resolved as of today.

Seeking to diversify member of the Distance Educ Committee

The ITC was asked to present to all ARC Deans on Regular Substantive Interaction (RSI) in distance education classes. Working with Institutional Research to assess faculty feelings about and understanding of RSI.

Department chairs should also receive.

The Department of Education has said that RSI can only be accomplished via live, synchronous instruction.

In the Spring the ITC created a one-page fact sheet for all faculty who could not attend the FLEX event.

Plans to keep the Academic Senate updated on changes to Canvas outside of once-per-semester reports/communication.

Request for clarification on where to post committee agendas and minutes/notes (possibly on the Acad Senate Canvas site?)

15. Program Pathways Committee (Bill)

Written report included in supporting materials

Been a busy year for the committee. Every single program map has been updated on the website (in advance of the upcoming catalogue). All switched to the new CALGetC pattern/pathway).

All degree maps (260-280) have new GE patterns.

Had to look through every note on every map and replace language and references that are now outdated.

Biggest thing (only one not reactive to State-level changes/legislation): added course prereqs to all courses to assist students understand the sequence and get into the right courses.

Encouragement to check your program's current program maps.

ADTs still being changed because they're trying to bring the UC's into it.

Math placement is likely to change in the next year, but it is uncertain.

Opening for a CTE member who is interested in serving on the committee

16. Professional Standards Committee (Michael)

Type A/B Leave Committee met multiple times this semester

Very vague language around dates and deadlines for leaves application (August 15th)

Strong encouragement to put that application together for Type A or Type B leave.

September 15th will be the new deadline for submitting applications for Spring and February 15th for the Fall

Goal: to minimize the impact on FTE allocation that faculty, chairs, and management have to navigate

Did not have a lot of FTE this year to award (2.00 Annual FTE Type A Leaves; .842 FTE Type B)

Had some FTE leftover: Type A (1.00) Type B (.142 Spring 2026 only)

Type A: 100% leave where you will not be teaching or counselling

Type B: Partial leave to undertake a project that benefits the College in some capacity (curriculum is not often considered to be covered under Type A/B leaves)

Any projects, within reason, are potentially supported through Type A/B leaves

Reports of the Type A/B products are due 3 months after the completion of the leave (past reports available in the library and online)

17. Dual Enrollment Taskforce (Veronica)

Preliminary report available in supporting materials (final one coming soon)

Preliminary key recommendations (not final)

Need to establish an Academic Senate Dual Enrollment Committee (not just a taskforce)

Need to critically revisit the goals/mission of Dual Enrollment as a College program

Instructional and Counseling coordinators are needed and strongly recommended

Need clearer professional development for faculty teaching high school students in both

CCAP and non-CCAP instructional contexts.

Urges to create a page under the ARC Insider website for faculty and staff involved in Dual Enrollment courses\

Discussion (10-15 minutes per item)

18. Brown Act (compliance and meeting modality)

As we move into Fall, the interest is to lift the "veil of ambiguity" to clarify expectations

Plenary discussed the practice of remote attendance (we have talked to our sister campuses in the District and only guests Zoom in at SCC and Folsom)

Brown Act is summarized in the supporting materials

Question: do we maintain the status quo (how things have run this year) or make changes to be in closer compliance with the Brown Act?

Feeling that people who commit to serving as a Senator should be ready and willing to come in person; it benefits the body by having folks physically present

What are the consequences for not being in compliance with the Brown Act?

There is no Brown Act jail. However, it casts aspersions on your body; could invalidate or harm the credibility of decisions made by the body.

The flexibility of remote attendance made it possible for several Senators to participate in the body. In the absence of remote participation, these people would likely not have agreed to serve.

Clarification: the goal is not to remove the Zoom option, but to properly monitor it so it is not abused. The goal seems to be to encourage engagement.
