- 6. President's Report:
 - a. ARC has new **Updated COVID Protocols**
 - i. ARC also has new COVID-19 Reporting Forms through a New Decision Chart
 - ii. The definition of close contact/exposure has changed from "within 6 feet of COVID positive person" to "in the same room as COVID positive person for a cumulative of 15 minutes in a 24 hour period."
 - iii. Individuals who have close contact/exposure need to wear a mask for 10 days.
 - iv. There is no longer PCR testing provided on campus.
 - b. Sample language you may include in your first day messages to students, syllabus, or course Canvas: As a student participating in our in-person learning experience, you are required to follow the Student Standards of Conduct which includes specific Public Health protocols. President Hoffpauir invited President Melanie Dixon to visit:

- Welcomed everyone and wanted to share updates.
- Shared that ARC is focused on enrollment but also the retention of students. ARC working with an enrollment management firm Gravenberg Consulting Firm (Outreach/Retention Planning).
- Ed Master Plan and PD Plan already up to date, so Institutional Equity Plan was the only one updated this past spring and moved through our councils.
- Student Center Funding Formula (SCFF) is tied to enrollment. This means ARC needs to focus on its sophomores, life learners. Sophomores specifically as they will be the entering class in 24-25 and also need to focus on our returning students and those lost since onset of the pandemic.
- ARC will be creating a 90-day action plan and faculty will have an opportunity to give feedback. The goal is to not have a million strategies but to narrow down strategies, and come together as a community to set up core principles. To ask ourselves "What are our core principles?" Faculty will get to opportunity to discuss. Changes to college will be done collectively. A few measurable strategies.
- ARC Accreditation visit on-ground October 10-12th.
- ARC is an HSI-serving institution, worked with a consultant, and submitted a 5-year HSI grant, and notification is expected in September. Once award a local team will be identified. If awarded a local team will be developed to begin implementation of proposal.
- Housing for students Land donated by the Mohammad Family (off of Myrtle Ave.) was initially appraised at \$650,000 and is currently at \$990,000. Currently building housing for students comes with restrictions such as no parking on street thus the number of units that could be built would make this option cost prohibited for students. The goal is to provide students with affordable housing. The pending question is how to leverage this land for greater capacity for longer term for our DI population and for gap measures.
- ARC, FLC and SCC have been awarded planning grants from system office to explore on campus housing. Would have to work with a property management company. This is just an assessment of what it would cost. This project would take years.
- Senator asked about the auto drop of students that occurred and the impact on DI populations. President Dixon acknowledged the challenges of being part of a multi-campus district and the impact of enrollment tied to vaccination requirement. Drops happened as a result of non-payment and non-compliance with vaccination requirement. Drops should have only happened for students with on-ground classes. The timing was not ideal, contributing to some of this was a breakdown of communication and failure to use HEERF dollars to help students under the "non-payment" category. There was a lack of clarity regarding the list, ideally, there should be some local control, however, the vaccination mandate will result in decreased enrollment. Decision not to use HEERF to waive all student balances. Correlation between enrollment decline and vaccine requirement.
- A Senator asked what if a faculty or student test positive? The vaccination requirement is a Board of Trustee decision. This decision may not be changing until Spring 2023. The decision might be impacted by boosters and other factors.
- The institution will continue to invest in Hyflex/Synflex technologies.

- Campus Communication people are trying, working with the structure we have. For example, ARC does have a Public Information Office (PIO), but he is supervised by AVC and assumes district-wide responsibilities. Therefore, President Dixon came with a communication plan. A multi-prong approach will release a monthly newsletter with any updates (cadence still being worked out), and the VP's will take it to their areas to share out, to then have them share out their areas. President Dixon will hold office hours for more one-on-one, will continue with College Exchange more group settings. The goal is to be responsive to how individuals want to engage with her. The Exchange meetings will be recorded, uploaded to the website, and searchable. Decision-making will focus on our values and will focus to avoid missteps.
- A Senator wanted to acknowledge all the work ARC had done in giving over \$20,000 in books and tablets to students. This positively impacts students' academic journey.
- The campus continues to do incredible work with the OER project and has big impacts on students. President Dixon has personally received positive feedback from students in appreciation of this work.
- Working with Follett regarding students with Financial Aid, when they haven't received their disbursement check.
- We have to address the rigidness within our district. We must center what we do on our values and where we might have some flexibility.
- Acknowledges the changes and impact of AB705/1705 on faculty. President Dixon appreciates all the work faculty have done in this effort.
- Reparations returning cultural items and ancestral remains to their communities.
 Faculty are being asked to look in their area for any cultural items and ancestral remains that should be returned. A survey will be sent out asking Faculty to look around their area for cultural items and ancestral remains. Please be on the lookout for this survey.

 - a. Fall 2021 ARC Submitted ISER and received core inquiries 4 for ARC and 2 for the District. ISER Team additional evidence request regarding:
 - Institutional Set Standards The team would like to understand what action for improvement the institution takes when it does not meet its own institution-set standards.
 - ii. **Facilities Master Plan** understand the college's role in using the facilities master plan and long-range capital plan to support institutional improvement goals for new facilities and equipment, which includes projections of the total cost of ownership.

Some of the random courses reviewed by the ISER team were synchronous online courses, thus those were removed. Alisa Shubb and Bill Simpson continue to work with Frank in preparation for the site visit. Accreditation visit on October 10-12th.

 - a. CTL's goals and funding are grounded in student success, anti-racist practices, and supported by the Disportionate Impacted Reports. CTL has a diverse list of offerings facilitated by ARC Faculty trainers that include Pam Chao, Marianne Harris, Veronica Lopez, and Jeff Sacha. In addition, will have outside facilitators.

 - a. DAS President during the summer pushed back on a request of Trustee Pam Haynes to have the Board of Trustees write a resolution in support of AB705/1705. President Shubb gently reminded the Board that Faculty are not present in the summer to provide input.
 - b. BOT is interested in learning more about how ESL, Math, and English are providing support and re-vamping courses to help students.
 - c. BOT wants to make sure that students' needs are being met.
 - d. Senator suggested in addition to smaller class sizes, what about making class longer? A senator suggested an alternative approach, by adding a discussion section to the course. There was concern that students might already be already overwhelmed, thus making a class longer might overwhelm students even more.

In addition, some history faculty feel as if the high school districts want faculty to conform to their requirements (ie become high school teacher) rather than high school encouraging their students to take college-level courses with college professors.
 - b. The pandemic has taught us that we can work differently. For example, SynFlex. Is the pressure to be back on campus from DO or campus? How are we listening to what students want?
 - c. What is the rationale for why counselors are required to return to counseling on campus when we only meet with students over the phone or via zoom? Students come into the counseling dept., but do not see a counselor at this point.
