# 11.1 F23-R01: Senatorial Stipends

This time is reserved to discuss and potentially take action on a resolution draft submitted to the Senate for Senatorial Stipends.

- The Senate is understaffed and a stipend would be an incentive. The maximum that could get paid is \$600 per semester.
  - This is reduced by rank
    - Amount is outlined per rank and determined in expectation of full senate
  - Will be enacted as bylaws after the funding is passed
- One example, public statements of reasons for excused absences is problematic
  - o i.e. medical issues, private matters
  - Topic of moving public matters to private was discussed
- If joined halfway would they get paid?
  - o yes
- Triumph bonuses

- Up to 600 dollars for the entire semester
- If someone wants the triumph, they need to request it
- One would need to make sure that everyone is doing the work outside the meeting
- ASB needs to vote on the approval of the stipend itself
  - Triumph can be open for voting
  - Voting for attendance can be open to abuse
    - If an individual does not show up anyway, will be dropped
- Voting on emergencies
  - there should be a deadline on the determination of excused absences
  - Strict deadlines would cause problems
- Two things
  - Why is this stipend just for the senate?
    - Max comment is planning on getting rid of CAEB
      - This is an extremely long process and needs to be voted upon first
      - Why make a resolution that is based on another resolution that has not been passed yet?
      - Max senate does more work than CAEB
        - Comments on this are discussed
        - Many say it is not fair for CAEB to be excluded

- It has been known that Davies hall has been crumbling for ten years
- The right decision was made to get everyone out and tear it down
- Board of trustees has known the entire time
  - Senators will attend the board of trustees meeting and show up for public comment
  - For ten years, the students were not the main focus
- Emphasis for our presence to be known
- Emphasize students position
- Start advocating for students on a district level

#### 11.4 ASB Apparel Bill F23-XX
