Re-Opening Plan	Frank Kobayashi	<ul style="list-style-type: none"> <li>- Started with impossible to convert at the start of the semester - went well</li> <li>- Next went with difficult to convert (science labs, etc.) - went well</li> <li>- February 22 remainder of scheduled face-to-face will return to campus</li> <li>- Enrollment is down across the district (ARC down approximately 8.5%)</li> <li>- Every day is a new adventure</li> <li>- Students are very appreciative of being able to be in the classroom</li> <li>- With the third wave coming up, any targeted communication to those faculty about what to do and not to do, etc?</li> <li>- Will put together a guidance document and push it through the deans for distribution</li> <li>- Provide information about food, coffee, etc.</li> <li>- Are we going to have folks around campus on the 22nd who can answer questions of students (i.e., where are services located, restrooms, etc.)</li> <li>- All services and hours will be published prior to the 22nd</li> <li>- Welcome tables will be around campus with volunteers</li> <li>- Is there a dashboard with student vaccination status</li> </ul>
Accreditation	Frank Kobayashi / Bill Simpson	<ul style="list-style-type: none"> <li>- ARC's ALO (Accreditation Liaison Officer) is now Frank Kobayashi</li> <li>- Bill Simpson is Faculty Co-Chair</li> <li>- ISER submitted to ACCJC in December</li> <li>- ISER team has been formulated</li> <li>- Team has read our ISER</li> <li>- Week of February 14 is deadline for the team to make requests of the college for further information (one week turnaround)</li> <li>- February 17 will be Accreditation Open Forum</li> <li>- Campus community has that opportunity to share any information with the team</li> <li>- End of February will receive information from ISER team on those areas (core inquiries) they wish to further explore</li> <li>- Campus visit is scheduled for October 10</li> <li>- Received good initial response from ISER team chair</li> <li>- Executive team will not be present at the Open Forum</li> </ul>

Personnel Updates	Melanie Dixon	<ul style="list-style-type: none"> <li>- An interim dean overseeing research is currently in the recruitment/hiring process</li> <li>- Interim will be in place for spring and fall semesters</li> <li>- Permanent position will be advertised in FI22 for a Sp23 start date</li> <li>- Also looking to add a researcher position</li> <li>- All in efforts to build capacity to provide actionable data</li> <li>- ITC, CTL and research will all be located in one space</li> </ul>
Nongendered/single-stall restrooms signage	Cheryl Sears	<ul style="list-style-type: none"> <li>- September 2016, AB1732 required signage for single stall restrooms</li> <li>- Symbol was triangle superimposed over a circle</li> <li>- In 2018, DAS (State Architect) mandated signage</li> <li>- A year later, temporary signage with additional language were posted by staff</li> <li>- Temporary signage removed as a result of student concerns</li> <li>- With a majority of buildings on campus still locked, access to single staff restrooms remains a challenge</li> <li>- Questions coming forward again about additional signage and providing restroom access in Davies Hall</li> <li>- What is the need of students? Our good intentions may not meet the needs and interests of our students</li> <li>- Interest in gathering more information from our students</li> <li>- Thinking about venue of further discussion about removing "faculty only" restrooms</li> <li>- No mechanism to get feedback from our students either</li> <li>- Next step is to have a discussion about how to get input from the students</li> <li>- Any projected time when the consultant's report will be ready</li> <li>- A few more eyes at the DO need to review it prior to dissemination</li> </ul>
