Special Presentation: Davies Hall FPP	Koue Vang	<ul style="list-style-type: none">-Davies Hall FPP Kickoff Meeting-A replacement facility for Davies Hall qualifies for state funding under “Category A-1 Health and Life Safety Projects”-Requirements:<ul style="list-style-type: none">-Must be the least cost permanent solution-No increase in space-No changes to the programs housed within the building-No changes to the types of spaces housed within the building-The total assignable square feet (ASF)* for each category of space must be equal to what was existing in that category-Proposed basics for the FPP development:<ul style="list-style-type: none">-Total ASF is set to be 35,340 by the state-Gross square footage (GSF) will be between 54,000 and 57,000 to be within efficiency factors expected by state and district (between 65-62%)-Building is proposed to be 3 story-ASF/GSF sizing is almost identical to the new STEM building next door
