| Special Presentation: Davies Hall FPP  | Koue Vang  | <ul style="list-style-type: none"><li>- Davies Hall FPP Kickoff Meeting</li><li>- A replacement facility for Davies Hall qualifies for state funding under "Category A-1 Health and Life Safety Projects"</li><li>- Requirements:<ul style="list-style-type: none"><li>- Must be the least cost permanent solution</li><li>- No increase in space</li><li>- No changes to the programs housed within the building</li><li>- No changes to the types of spaces housed within the building</li><li>- The total assignable square feet (ASF)* for each category of space must be equal to what was existing in that category</li></ul></li><li>- Proposed basics for the FPP development:<ul style="list-style-type: none"><li>- Total ASF is set to be 35,340 by the state</li><li>- Gross square footage (GSF) will be between 54,000 and 57,000 to be within efficiency factors expected by state and district (between 65-62%)</li><li>- Building is proposed to be 3 story</li><li>- ASF/GSF sizing is almost identical to the new STEM building next door</li></ul></li></ul> |
